

## Administrative penalties for false labeling of lithium batteries

What are the consequences of not complying with lithium battery shipping regulations?

The FTC has taken enforcement action against Lithionics and Tartagliafor making false 'Made in USA' claims. The proposed order settling the FTC's complaints requires Lithionics and Tartaglia to shut down these bogus claims.

#### Can Americans buy American lithium ion batteries?

"As our country works to onshore production of lithium ion batteries, it's critical that honest businesses have a chance to compete, and that consumers can buy American," said Director Sam Levine of the FTC's Bureau of Consumer Protection.

The penalties for violating lithium battery regulations are severe and vary depending on the nature and intent of the violation. Civil penalties can range from \$27,000 to \$90,000 per day for ongoing infractions, while willful violations can lead to fines up to \$250,000 and imprisonment.
