

# Battery process production design and manufacturing

What is battery manufacturing process?

Figure 1 introduces the current state-of-the-art battery manufacturing process, which includes three major parts: electrode preparation, cell assembly, and battery electrochemistry activation. First, the active material (AM), conductive additive, and binder are mixed to form a uniform slurry with the solvent.

What are the production steps in lithium-ion battery cell manufacturing?
