Non-rechargeable lithium batteries (primary cells), such as lithium metal or lithium thionyl chloride batteries, are generally not allowed in checked luggage. These batteries can be volatile and present a fire risk.

For all returns, DOT and FAA regulations require that lithium batteries ship via sturdy, specially-marked boxes with static-free wrapping. All battery returns must be shipped in UN-spec boxes and packaged according to federal regulations. Packaging is available from your local UPS Store or Fedex/Kinkos store.

In my opinion - you should swap these batteries once in a month and discharge battery to 40-60% before storage. Lithium Ion batteries "go bad" when they are stored in discharged state. It is all about battery voltage. If voltage is too low - undesireable chemical reactions will happen and battery will degrade.
