How long do EV battery warranties last?

However,most EV battery warranties come with an important caveat; the maximum charge capacity of the battery can fall to a certain percentage in those eight years, without it being considered broken. This is usually pegged at 70 percent.

How long is a battery warranty on a car?

For example, if you shop through Hyundai, you see an industry-leading 10-year, 100,000-mile battery warranty, with the caveat being your battery has to fall below 70 percent capacity during ownership to qualify for a replacement. Kia has a similar offering, outpacing even Tesla.
