

Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

One of the main functions of energy storage, to match the supply and demand of energy (called time shifting), is essential for large and small-scale applications. Is energy storage a future power grid?

For the past decade, industry, utilities, regulators, and the U.S. Department of Energy (DOE) have viewed energy storage as an important element of future power grids, and that as technology matures and costs decline, adoption will increase.

What is energy storage medium?

Batteries and the BMS are replaced by the "Energy Storage Medium", to represent any storage technologies including the necessary energy conversion subsystem. The control hierarchy can be further generalized to include other storage systems or devices connected to the grid, illustrated in Figure 3-19.
