Nearly half of all states have enacted laws protecting homeowners" rights to install solar panels. These laws generally prohibit HOAs from outright banning solar panels within their communities. Solar access rights can fall under one of two types -- solar access laws and solar easements.

First, it prohibits HOAs from banning solar energy systems outright. This means that if your HOA has a blanket "no solar panels" policy, it's likely in violation of state law. Second, the act allows HOAs to impose reasonable restrictions on solar installations.

Colorado House Bill (HB) 21-1229, which passed in 2021, increased protections for property owners within HOA-guided communities. Specifically, the bill keeps HOAs from prohibiting the installation of various home additions, including renewable energy-generating devices such as solar panels.
