

# How to define the warranty of new energy batteries

What is a warranty for battery energy storage systems?

Warranties for Battery Energy Storage Systems (BESS) provide mechanisms for buyers and investors to mitigate the technical and operational risks of battery projects, by transferring the risk of defects or performance issues to the manufacturer or the battery vendor.

### Is a battery warranty a warranty?

And warranty is in fact only a guarantee against manufacturing defect. A warranty statement can only assure a user that if he follows accepted and documented maintenance practices as outlined by the manufacturer, the battery (or cell) is warranted against manufacturing defect for a specific period of time.

The claim must be made within the warranty period listed on top of the battery. Dated proof of purchase is required.
