Which Chinese companies invest in US solar equipment factories?

Here is a list of Chinese companies investing in U.S. solar equipment factories: Illuminate a joint venture between Chinese solar equipment maker Longi (601012.SS) and U.S. clean energy project developer Invenergy. The company started producing solar panels at a five-gigawatt plant in Pataskala, Ohio in February.

How much has China spent on solar panels?

About 14.5 gigawatts is already online,accounting for nearly a third of U.S. panel-making capacity.
