What is a lead acid battery?

The equation should read downward for discharge and upward for recharge. The battery which uses sponge lead and lead peroxide for the conversion of the chemical energy into electrical power, such type of battery is called a lead acid battery. What is a lead acid battery container?

The container stores chemical energy which is converted into electrical energy by the help of the plates. 1. Container - The container of the lead acid battery is made of glass, lead lined wood, ebonite, the hard rubber of bituminous compound, ceramic materials or moulded plastics and are seated at the top to avoid the discharge of electrolyte.

What are the components of a lead-acid battery?

When a lead-acid battery is discharged, the main component of the positive electrode is lead dioxide, and the main component of the negative electrode is lead. In the charged state, the main components of the positive and negative electrodes are lead sulfate [43,44].

What is the construction of a lead acid battery cell?

Separators. Anode or positive terminal (or plate): The positive plates are also called as anode. The material used for it is lead peroxide (PbO_2).

Lead - acid batteries feature a Pb-based anode, typically composed of PbO_2 on a Pb substrate. NiMH batteries use a hydrogen-absorbing alloy, such as a mixture of nickel (Ni) and metal hydride, as the anode material. The anode absorbs hydrogen ions during charging and releases them during discharge.

The following half-cell reactions take place inside the cell during discharge: At the anode: $Pb + HSO_4^- \rightarrow PbSO_4 + H^+ + 2e^-$ At the cathode: $PbO_2 + 3H^+ + HSO_4^- + 2e^- \rightarrow PbSO_4 + 2H_2O$. Overall: $Pb + PbO_2 + 2H_2SO_4 \rightarrow 2PbSO_4 + 2H_2O$. During the ...
