Under the PTC program, solar energy project owners or entities can claim a tax credit based on the electricity generated by their systems. The credit amount is determined by the kilowatt-hours (kWh) of electricity produced. As of the Department of Energy's latest information, the PTC for solar energy projects is 2.75 ¢/kWh.
